### **PLAN OF ACTIVITIES.**

The Chamber is envisioned as the bridge between the Economies, Cultures, and Peoples of Mozambique and Nigeria, engendering strong mutual cooperation and respect. It has a four point focal agenda in the following areas:

- Investment, promotion of the flow of Direct Foreign Investment.
- Agriculture
- Mineral mining and Energy Resources
- Culture, Friendship and International Education.

Upon inauguration, a vigorous nationwide campaign on Agriculture will kick off. The program is code named “**school to farm program**”, it is aimed as sensitizing youth population to engage in productive Agricultural practices, with a view to making Mozambique self sufficient in Agriculture in Ten years. This will be closely followed by other planned programs some of which may run concurrently.

8. The Chamber shall collate and forward all the necessary data and information on the economic and developmental needs of both countries to members as well as other potential investors to encourage private sector participation in the financing and

execution of the said projects. It shall also make available information concerning sales, acquisitions and investment that may exist in the two countries.

9. The Chamber shall organize exchange teams of professionals and specialists as well as resource teams on regular visits to the two countries; it may promote this program by the organization of international talk shows, seminars, workshops and symposia involving the two countries, especially in their areas of interest.

10. The Chamber shall organize and host regular conferences and bilateral summits to acquaint members of the opportunities that exist in the two member nations; it may also use this forum for the improvement of knowledge by way of capacity building and trainings.

11. The Chamber shall align with chamber of commerce of both countries to enable it offer the best of services and assistance to its members, these may include legal and technical assistance related to their business.

12. The Chamber shall organize and host trade and cultural shows from time to time in the two countries.
