The works done by implementing agent was as expected as follows:-
 - *Awareness of child labour in Tobacco growing communities was great.*
 - *The empowered committees continued to educate their communities on child labour so that to meet positive expectation of the project to their premises.*
 - *To identify 94 vulnerable childrens who are doing Tobacco farming works and hence to rescue them in working hazardous activities.*

 - I. **Village Government leaders:** - **are** very important people to inspire the communities accepting the project. *They supported us to form VCLC (Village child labour committee) to combat the issue within farming Tobacco communities,*

 - II. **Religious leader:** *They supported us to explain child labour cases in worshipping houses based on beliefs, The sensitized the community to stop child labour by using the word of God that is wrong to involve children in working tough jobs which against laws of the country and human rights.*

 - III. **Teachers:** *They supported us to know the effect of child labour in schooling programs. Teachers are positive sounding in combating ignorance in the communities.*

 - IV. **Political leader:** *They do use their political platforms to proclaim children human rights to their followers and stopping child labour.*

3. What are the views of the target group(s) by sex, age and other social status as appropriate on the usefulness of the outputs of the

Implementation Agreement in meeting their needs?

Children with the age of 14-17 years

We have experienced the following views:-

- They declared this issue is bad to them because they experienced diseases, fever illness caused by tobacco insecticides chemicals.
- Stopping schooling programs by their parents / guardians.
- Violation of human rights and accessing education
- Loss of sightings caused by working direct in the sunlight for a long time.
- Tiredness of body, blinding problems and frequently illness.
- Bitten by snake and other wild animals in the forest and farms.

Parents / Guardians: They said

- Mental retardation and illness,
- Missing accessing education
- Poor academic performance for those who work and study.
- Some of the children are unhappy to enjoy life.

Teachers: They said

- School pupils dropouts
- Poor academic performance for those who work and study.
- Decreasing of children enrollment to start schooling

Government village leaders: They said

- Children's are missing their rights to enjoy life and accessing education.
- They said community should stop child labour

4. Describe the effects of the Implementation Agreement on the situation of the target group(s) by sex, age and other social status as appropriate.

Positive effects:-

- Awareness of knowing children's human rights to children and adults that human rights have to be protected.
- Total of 94 (51me, 43fe) children's identified and has exposed to be aware on this issue.
- Farmers they understood child labour effects
- Initiatives to protect children human rights
- Formation of committees to combat the problem and now are functioning.
- Poor academic performance for those who work and study.

Positive effects:-

- We observed early pregnant cases for girls under 18 because of Tobacco industry.
- Poverty of communities resulted child labour

- Children in drugs
- Missing accessing schooling programs to children, increasing of children who are not completing school, increasing of children who are finishing studies without knowing Reading, Writing and Counting.

We used the following approaches:-

- Seminars and Trainings
- Forming committees to combat child labour
- Brochures and local radios programs
- Kanga and T-shirt painted combating child labour message

"Tuseme Hapana kwa utumikishwaji wa watoto na ndiyo kwa Elimu bora ya watoto wetu"

- Sports and games where we formed two teams to play football match with public strong message to combat child labour.

- In gender and age perspective, men were many and responded and was supportive than woman, although the fact is woman are engaged directly to child issue than men.

1. To eradicate child labour in Migungumalo village.

Challenges seen:-

- After identifying children from child labour, some of the parent's parents they were refused children to attend entrepreneurship programs and skills in developing self reliance skills. SLIC we

continued educating them and finally they started allowing them.

The achievements from each objective were as follows:-

1. There is increasing of child labour awareness and some of the parents they accepted to bring children back to school.
2. A total of 94 (61male, 33female) children were identified and revealed.
3. Villagers and government leaders they united together during carrying out the project.

1. How the achievements of the Implementation Agreement could be made sustainable, i.e. to what extent are the effects and impact durable after withdrawal of ILO funds?

Sustainability:-

- Formed committees on children were made to continue educating the communities to combat child labour continually.
 - Bylaws in the village formed by government leaders will enable farmers to stop child labour.
 - The implementer's agent (SLIC) will visit the committees to trace the progress of the project for the interval of every three months.

 - The technical and administrative support provided by the ILO was Adequate sufficient because nothing we lack during implementing. They were available, cooperative, love and smart communication.

 - Gender case was a problem because only men were involved more than women's.
 - Only men was identifying vulnerable children and woman's they do afraid their husband. Woman's has no rights to speak or decide before her husband.
 - In forming committees; they were many men's than women because of their husband to refuse them attending development programs.

Our success contributed by the following factors:-

- Presence of strong village government
- Presence of special child labour eradicating committees
- Educations and awareness through seminal and trainings rose within farming communities.
- Good cooperation and relationship between ILO and SLIC
- Usage of Kiswahili language in project activities

Factors affected negatively project implementation

- Traditions and customs
- Gender equality where mans involved more than women's
- Ignorance's cause by some communities to be uneducated

Findings:-

- *Community awareness to combat child labour and to accept human rights*
- *Availability of illness to children like eye illness, stomach and skins*
- *Early pregnancies to girls and maternal death*
- *Existence of sexual transmitting diseases and HIV caused by ignorant and unsafe sex.*
- *Existence of patriarch system*
- *Readiness of community to participate development programs.*

Recommendation and lesson learnt:-

- *The need of having gender education to eradicate the patriarch system between men's and woman's*
- *Involvement education in development programs should be provided fully.*
- *Education of human rights like those of children and women should be provided.*

- *ILO and SLIC should keep cooperating and communicating smoothly even for other projects. ILO after doing PILOT projects like*
